Good Afternoon North East Family,

Please be advised that the District Office continues to maintain a COVID-19 dashboard on the nesd1.org website that parents can access for real-time information on the number of active on-campus and active off-campus cases. An on-campus case is one in which an individual was in school during his or her infectious period. An off-campus case is one in which the individual was not in school during his or her infectious period. All close contacts were notified.

Between the timeframe between December 19<sup>th</sup> through January 1<sup>st</sup> we were notified of 25 on campus cases and 17 off campus cases.

During the week of January 2nd, 2022, we received notifications of the following cases:

- 1 Davis student tested positive for COVID-19. This student is considered an on-campus case.
- 1 Davis student tested positive for COVID-19. This student is considered an off-campus case.
- 3 Intermediate students tested positive for COVID-19. These students are considered on-campus cases.
- 1 Middle school student tested positive for COVID-19. This student is considered an on-campus case.
- 5 Middle school students tested positive for COVID-19. These students are considered on-campus cases.
- 3 High school students tested positive for COVID-19. These students are considered on-campus cases.
- 13 High school students tested positive for COVID-19. These students are considered off-campus cases.
- 2 District employees tested positive for COVID-19. These employees are considered on-campus cases.

3 District employees tested positive for COVID-19. These employees are considered off-campus cases.

The health and safety of our students and staff is our number one priority. We ask that if you believe you have been in contact with anyone who may have symptoms of COVID-19 or you experience COVID symptoms, to please stay home and contact your health care provider. Symptoms of COVID-19 can occur 2-14 days after exposure. This list does not include all of the symptoms (CDC, 2021).

- Fever (100 degrees of higher) or chills
- Cough
- Shortness of breath or difficulty breathing
- Fatigue
- Muscle or body aches
- Headaches
- New loss of taste or smell
- Sore throat
- Congestion or runny nose
- Nausea or vomiting
- Diarrhea

If your child has any of the following symptoms:

(fever, sore throat, cough, diarrhea, vomiting, or severe headache)

they may have an illness that they can spread to others (CDC, 2021)

Stay home, call your doctor, and/or get tested

If your child or a family member is being tested for COVID-19, or your child or family member is asked to quarantine, we are asking that you please notify the school.
